 - a. <u>Steering Group</u>: Simon Neenan and Matt Woodfield are retiring, Steve Rayner has withdrawn from the Steering Group (to remove the Coordinator from decision-making), Richard Carpenter and Jethro Moore have offered to withdraw to make space for others. The following nominations have been received to fill these 5 positions (others may be put forward for co-opting after the AGM):
 - i. Existing Members: Richard Carpenter (Outward Bound Trust), Jethro Moore (Adventure Beyond)
 - ii. New Members: Stephen Davies (School Camp Ltd), Roger Lee (Hampshire & Cass Foundation Mountain Centre)
 - b. <u>Board of Directors</u>: Steve Rayner has also resigned as a Director. The following nominations have been received to fill up to 9 positions (others may be put forward for co-opting after the AGM):
 - i. Existing Directors: Mark Soanes (co-opted in October 2018, now needs to be elected formally)
 - ii. New Directors: Stephen Davies (School Camp Ltd)
 - c. Chairperson: Emyr Rees has agreed to continue in his position as Chairperson

7. Formal Dissolution of SWOAPG as an Unincorporated Association

The operations and assets of the existing unincorporated South Wales Outdoor Activity Providers Group have been transferred to a new Company Limited by Guarantee and the existing unincorporated association now needs to be dissolved formally.
